In the most recent Research Excellence Framework (REF), a nationwide assessment of research at universities published in December 2014, Hull University Business School was placed 37<sup>th</sup> among 101 UK business schools for research power (research quality x number of staff submitted).

### 赫爾大學商學院

赫爾大學商學院提供多個學士、碩士與研究生課程，為學員提供專業或學術發展的途徑。商學院享負盛名，同時獲得兩項國際權威認證(AACSB及AMBA)。其中，AACSB是一項專門為商學院而設的認證，全球13,000個工商課程中僅少於5%課程獲得此項認證；說明赫爾大學商學院持續為高等教育的質量提供保證，以及不斷提升其學位為國際就業市場的價值。英國卓越研究框架(REF)2014年的報告顯示，其研究能力(研究質量x提交研究的人員數目)為全英101家商學院中排名37。

The programme aims to provide students with a thorough knowledge and understanding of both the philosophy and functions of accounting. Students will acquire practical skills relating directly to the subject and a range of transferable skills that will become valuable assets in accounting or business organisations.

The programme enables students to:

- discuss and use accounting techniques;
- conceptualise and analyse situations faced by accountants;
- demonstrate professional skills relevant to a career in accounting.

## Programme Structure

The entire programme comprises 18 modules or 360 credits. Students are required to take 120 credits' worth of modules each year and may normally complete the entire programme in 3 years of full time study in the UK, but in Hong Kong, only the Second Year and Final Year modules are offered.

Students with the required qualifications, such as the Higher Diploma in Accounting approved by Hull University Business School, are qualified for direct admission to the Second Year of the programme, and are required to complete 9 modules over 3 semesters of study for graduation (180 credits).

## Entry Requirements

Applicants shall hold:

1. an Advanced Diploma/Higher Diploma/Associate Degree in Accounting awarded within the HKU system through HKU SPACE with a GPA of 2.0 or its equivalent; **or**
2. a related Higher Diploma or an Associate Degree offered by HKU SPACE or a Higher Diploma or an Associate Degree from other tertiary institutions in the area of accounting recognised by the University of Hull.

Graduates of the HKU SPACE Advanced Diploma/Higher Diploma/Associate Degree programmes recognised by the University of Hull are considered to have met the English requirement. In other cases, applicants should have proof of English proficiency by having:

- (i) a Grade E in the Use of English in Hong Kong Advanced Level Examination (HKALE); **or**
- (ii) Hong Kong Diploma of Secondary Education (HKDSE) Examination with minimum score of overall level 4 in English Language (with a minimum of level 3 in each skill); **or**
- (iii) IELTS with a minimum score of overall 6.0 (with no subtest less than 5.5); **or**
- (iv) Pearson Academic Test of English with minimum of 54 overall (with a minimum of 51 in each skill); **or**
- (v) recognised equivalent.

Applicants with other equivalent qualifications will be considered on individual merit.

## Duration of Study and Award

With maximum exemptions granted, students can complete the programme in 1 year in full-time mode. Upon satisfactory completion of the programme, students will be awarded the **Bachelor of Science With Honours in Accounting** by the University of Hull.

## Teaching Mode

The modules will be taught through face-to-face lectures conducted by both Hull and HKU SPACE lecturers\*. Each module comprises 42 contact hours in a combination of lectures and tutorials. There will be one block teaching of 18 hours of lectures conducted by Hull lecturers, and 18 hours of tutorials plus 6 hours of drop-in sessions conducted by HKU SPACE lecturers.

\* *Taxation (HK) and Business and Company Law (HK)* will be taught by local lecturers.

## Assessment

Assessment for most of the modules (except for the *Independent Study* module) is based on a combination of continuous assessments and final end-of-semester examinations.

In addition, all students are required to undertake the *Independent Study* on a topic of their choice in the final year. There will be no written examination for this module. Students will be assessed 100% by coursework comprising oral presentation and a written report.

## Professional Recognition



Graduates of the programmes will be eligible for exemption from the Professional Examinations of the ACCA.



BSc (Hons) Accounting meets the educational requirements of CPA Australia. Upon completion of the programme and meeting CPA Australia's core knowledge requirements, graduates can become Associate Members of CPA Australia. To advance to the qualified CPA Australia status, candidates will need to complete the Professional Level of the CPA Programme, which incorporates 6 postgraduate education segments and 3 years of practical experience.



Graduates of this programme will be eligible to enrol the Qualification Programme (QP) offered by HKICPA.

## Career Opportunities

The accounting function is essential for all business entities whether they are multinational corporations or small companies. The demand for accounting service has consistently been on the rise with the expansion of the Hong Kong and China economy. Therefore, the demand for educated and qualified accounting personnel to support different sectors of the economy is rapidly growing.

The HKSAR Government's strong emphasis on the 6 economic pillars rooted in innovative and knowledge-based industries has led to a strong local economy. The positive development of a CEPA agreement between Mainland China and Hong Kong has eased market restrictions, granting local accounting professionals direct access to the Mainland market. All these factors spur the demand for accountants with international credentials and exposure.

## Tuition Fee

The tuition fee\* for 2016/17 intake is HK\$12,300 per module (9 modules in total), payable in 3 instalments.

\* The tuition fee is reviewed annually and is subject to change without prior notice.

## Continuing Education Fund

Selected modules in the programmes have been included in the list of reimbursable courses for CEF purposes.

According to the terms and conditions of the CEF, students seeking reimbursement of the fees under CEF must not have obtained any other publicly-funded financial assistance, such as FASP, for the same programme/modules to avoid double benefits. ## Financial Assistance Schemes

The BSc (Hons) Accounting programme delivered in Hong Kong is successfully accredited by the Hong Kong Council for Accreditation of Academic and Vocational Qualifications (HKCAAVQ). Full-time students are eligible to apply for Hong Kong government grants and low-interest loans, i.e. Financial Assistance Scheme for Post-secondary Students (FASP) and Non-means tested Loan Scheme for Post-secondary Students (NLSPS).

## University of Hull/IC Scholarships

A scholarship for the 2016/17 academic year will be announced no later than October 2016. In the 2016/17 academic year, a scholarship of HK\$12,300 will be awarded to a new student enrolled in the BSc (Hons) Accounting programme with outstanding performance in AD/HD study.
